*The Mats F. and Catharina Linde Forsberg Foundation was founded in 2020 by Catharina Linde Forsberg and Mats Forsberg with the aim of promoting scientific research, mainly regarding dog and domestic cat reproduction but also ethology and diseases related to reproduction in dogs and domestic cats.*

### **The last day to apply is February 15.**

The applications will be assessed by an evaluation group with skills and solid knowledge in veterinary medicine and dog and cat reproduction. The evaluation group submits proposals to the Foundation's board, which decides which projects are to be approved grants. Granted funds will be paid from the month of June.

*Applications received after February 15 will not be processed.*
